2 Introduction

Semco Maritime Ltd is committed to preventing modern slavery and human trafficking in all aspects of our business and supply chains. We understand our responsibility to uphold ethical practices and respect human rights, and we are dedicated to creating a transparent and accountable environment for all stakeholders involved in our operations. We are members of Offshore Energies UK and a signatory of the Energy Services Agreement.

3 Organisational Structure

Semco Maritime Ltd is a wholly owned subsidiary of Semco Maritime A/S, a family owned global Engineering company headquartered in Esbjerg, Denmark. The principal activities of Semco Maritime Ltd are orientated towards the Oil and Gas and renewables market in the UK. Engineering services are provided for the full project lifecycle from FEED studies to EPCIC, along with the support of operations and maintenance of offshore assets and decommissioning activities. Globally we employ over 2000 staff, with more than 300 working in the UK.
